VII. EIGHT PRINCIPLES OF GOOD ANTI-TRAFFICKING LEGISLATION

Despite progress evidenced by the number of laws enacted, the 2012 Trafficking in Persons Report produced by the State Department's Office to Monitor and Combat Trafficking in Persons identifies over 55 countries as either not having legislation or needing to strengthen their legislation. The Report identifies areas of improvement needed for national laws ranging from strengthening legal tools for law enforcement to protecting the rights of victims.

What are the hallmarks of a good anti-trafficking law?

Stephen Warnath, an advisor to government leaders on the development and implementation of their human trafficking laws has set out a framework comprised of eight guiding principles that can help in drafting legislation, reviewing a country's law, and evaluating the implementation of a law.¹⁷ The following summarizes these guiding principles. This is not a comprehensive overview of the specific provisions or language that should be included in a piece of national law as there are many excellent resources that provide that information.¹⁸
